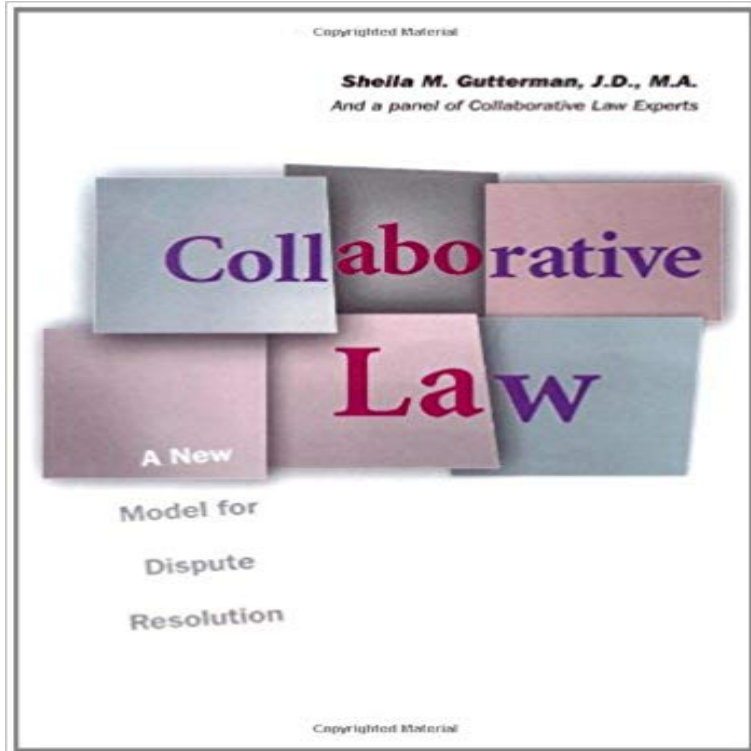


# Collaborative Law: A New Model For Dispute Resolution
