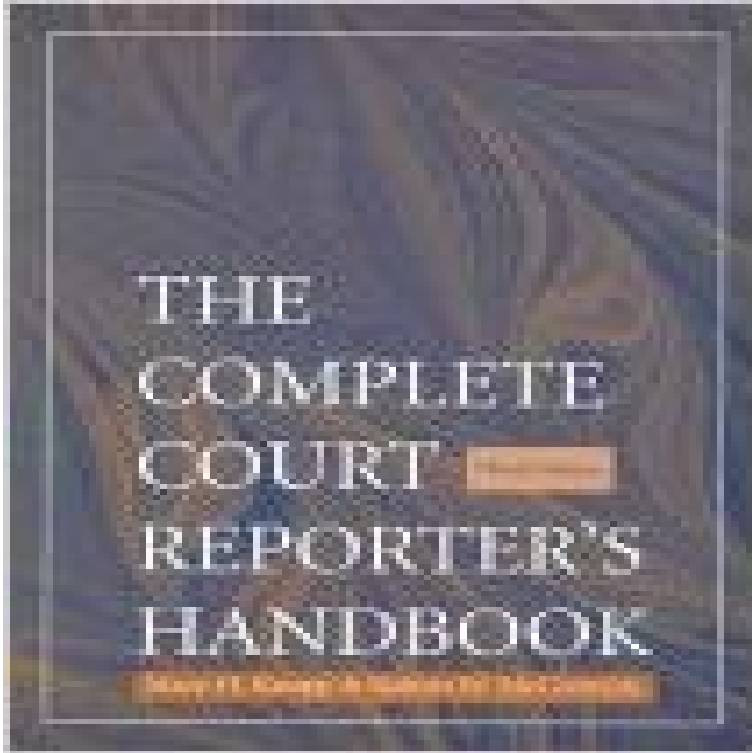


The Complete Court Reporters Handbook (3rd Edition)
