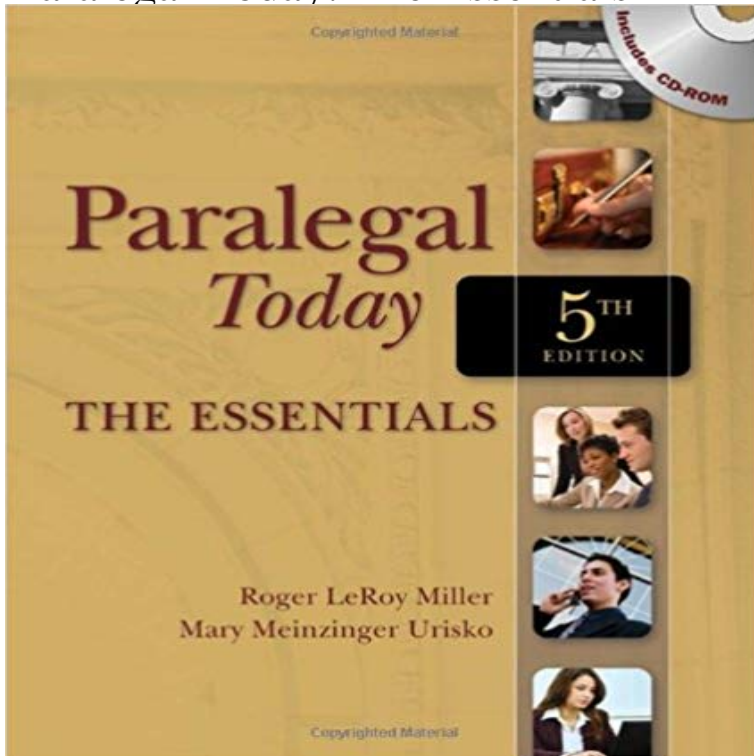


## Paralegal Today: The Essentials
