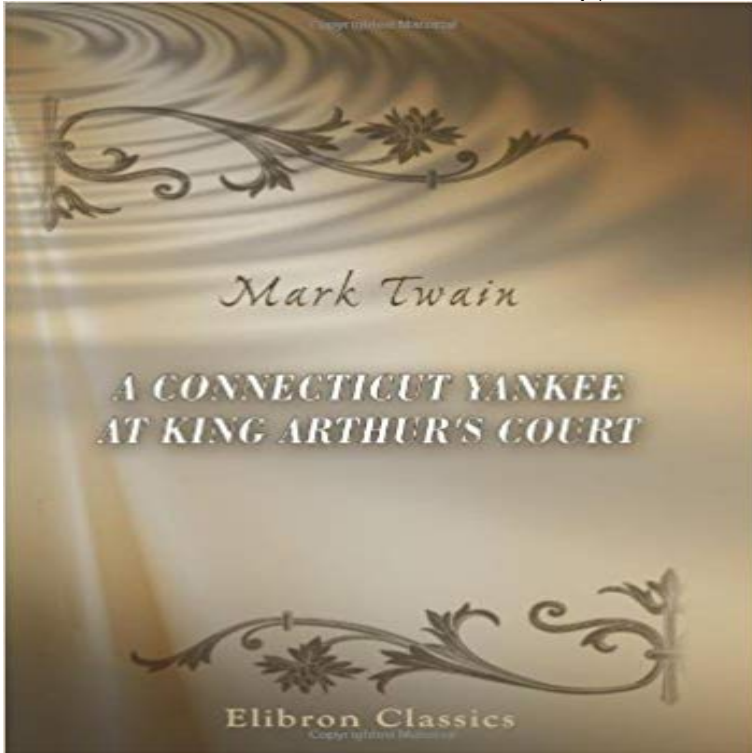


## A Connecticut Yankee at King Arthurs Court
