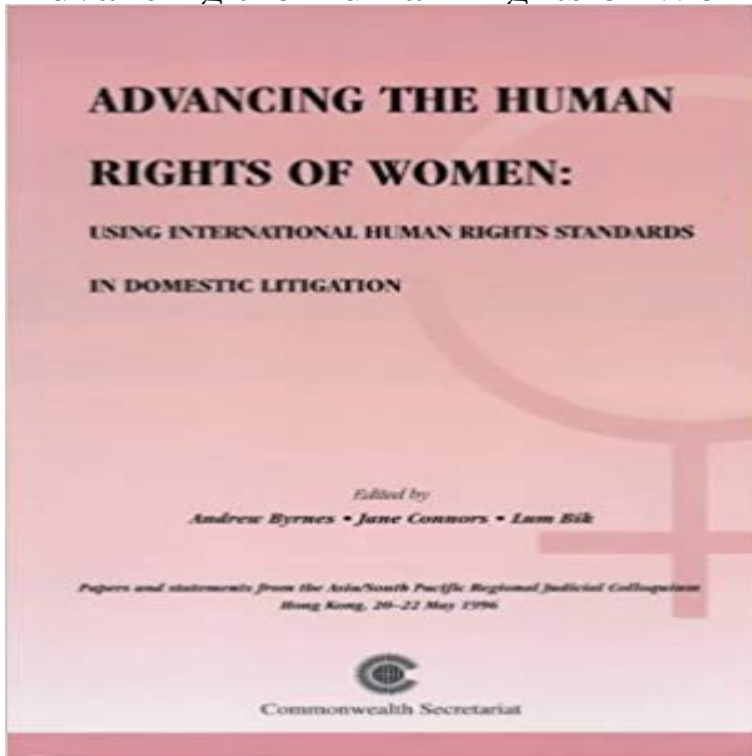


## Advancing the Human Rights of Women
