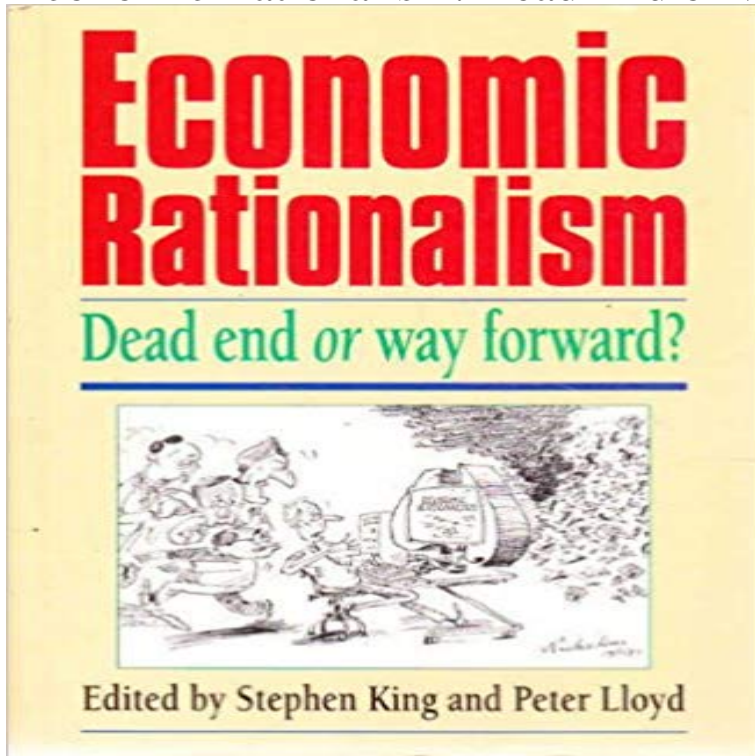


Economic Rationalism: Dead End or Way Forward?
