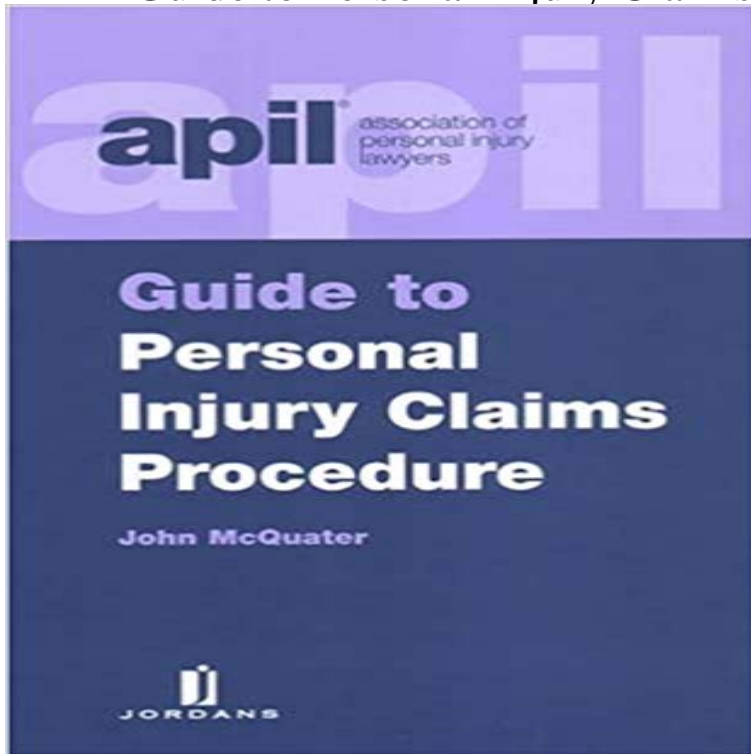


APIL Guide to Personal Injury Claims Procedure
