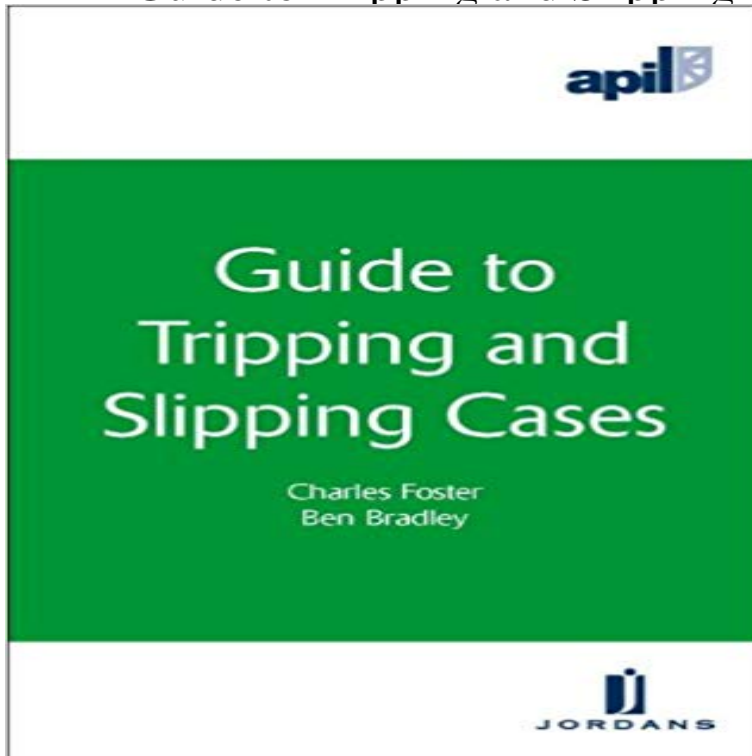


APIL Guide to Tripping and Slipping Cases
