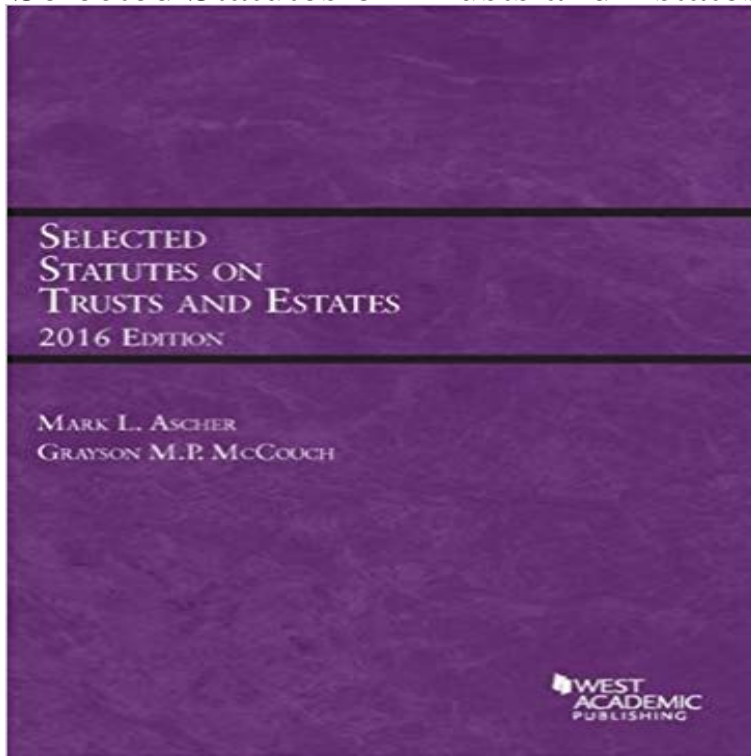


## Selected Statutes on Trusts and Estates
