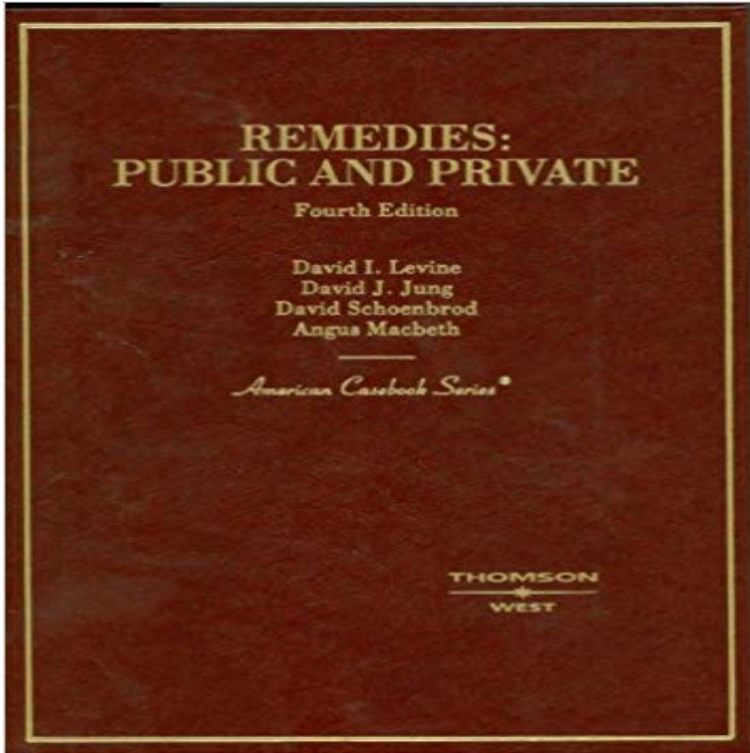


## Remedies: Public And Private 4th Edition (American Casebook Series)
