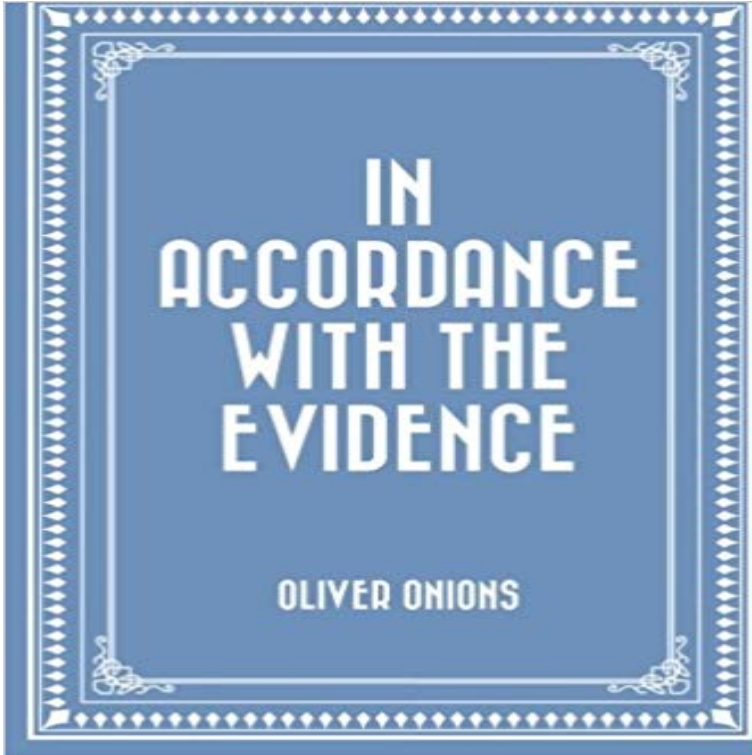


## In Accordance with the Evidence
