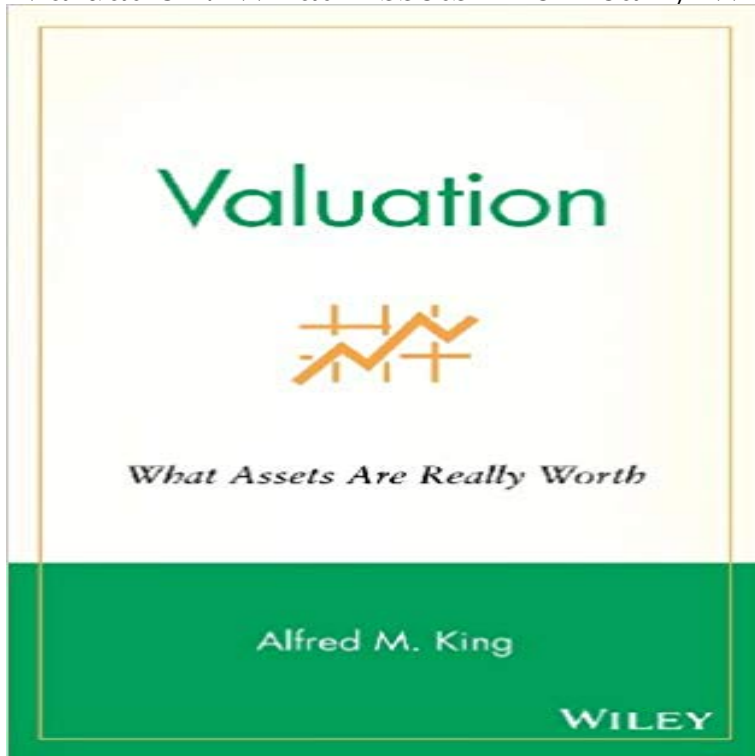


## Valuation: What Assets Are Really Worth
