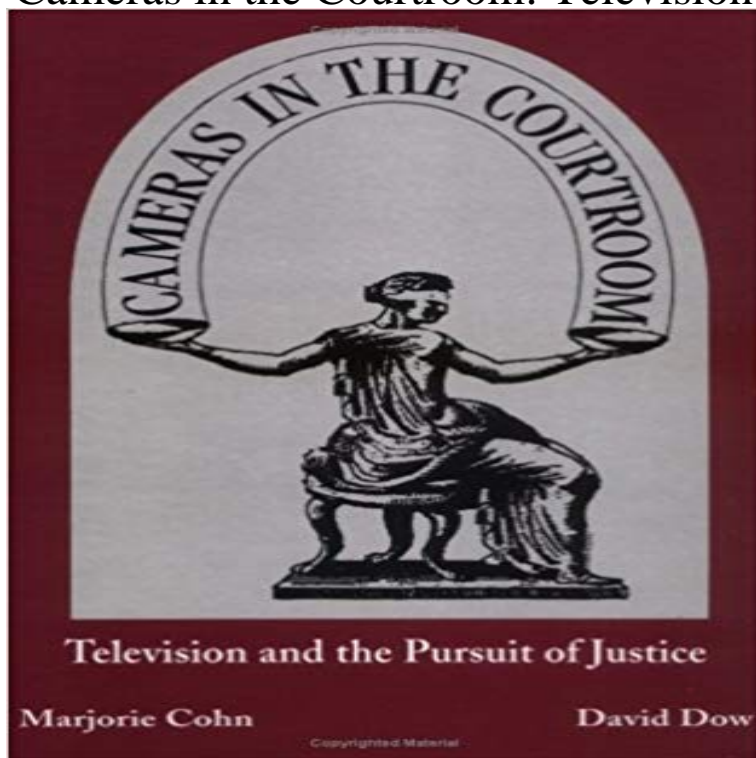


## Cameras in the Courtroom: Television and the Pursuit of Justice

Why the courts, including the Supreme Court, have traditionally excluded cameras is fully covered, and an historical perspective on televised trials is provided.
