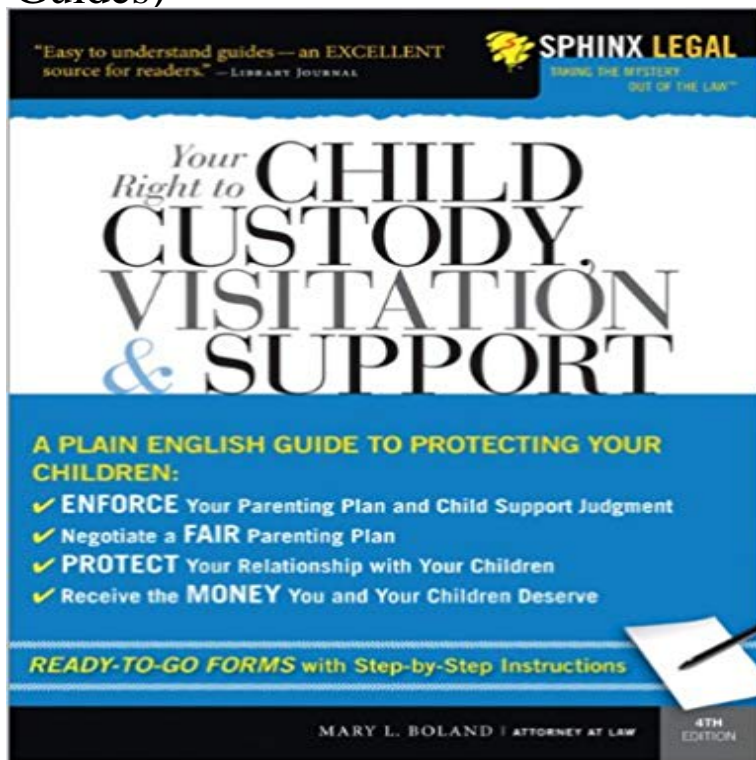


# Your Right to Child Custody, Visitation and Support (Legal Survival Guides)
