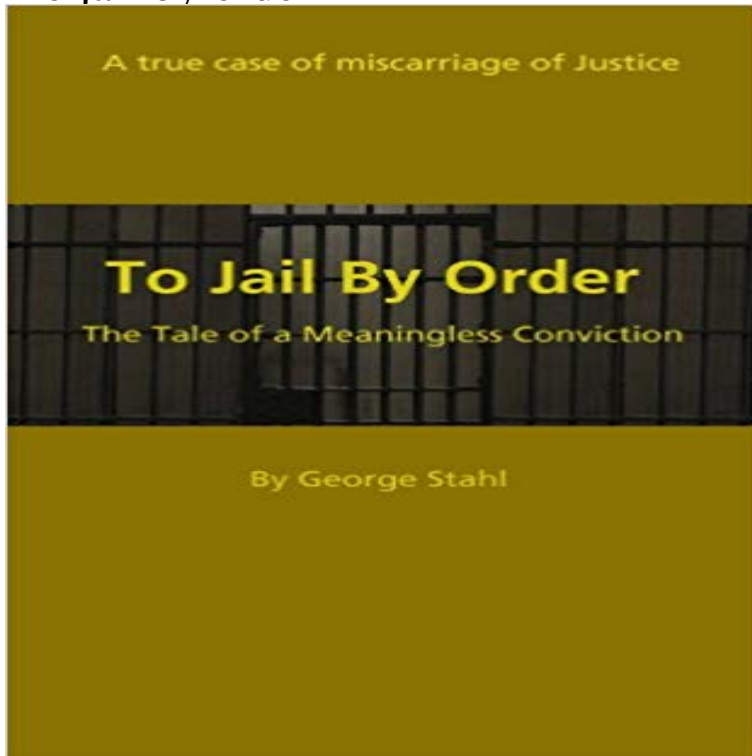


## To jail by order
