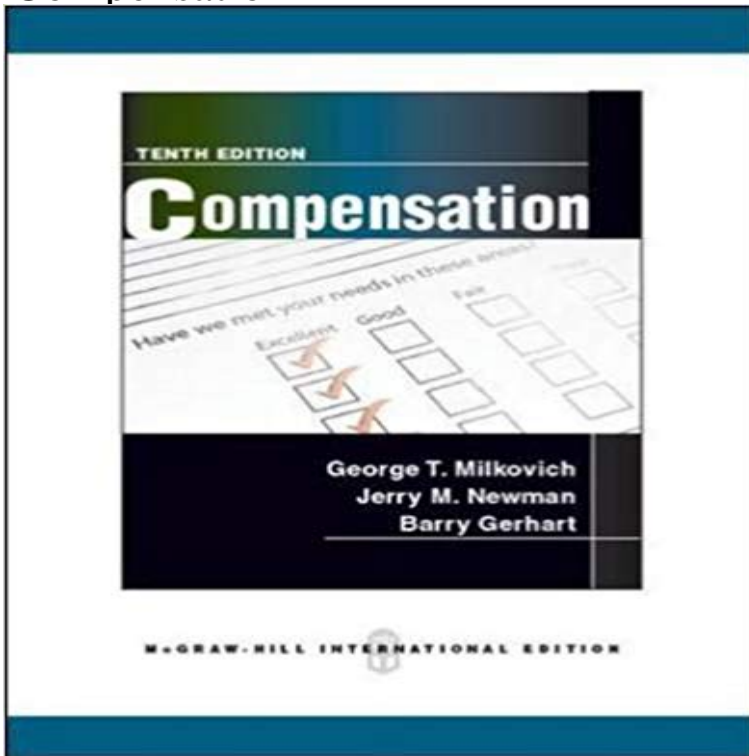


Compensation
