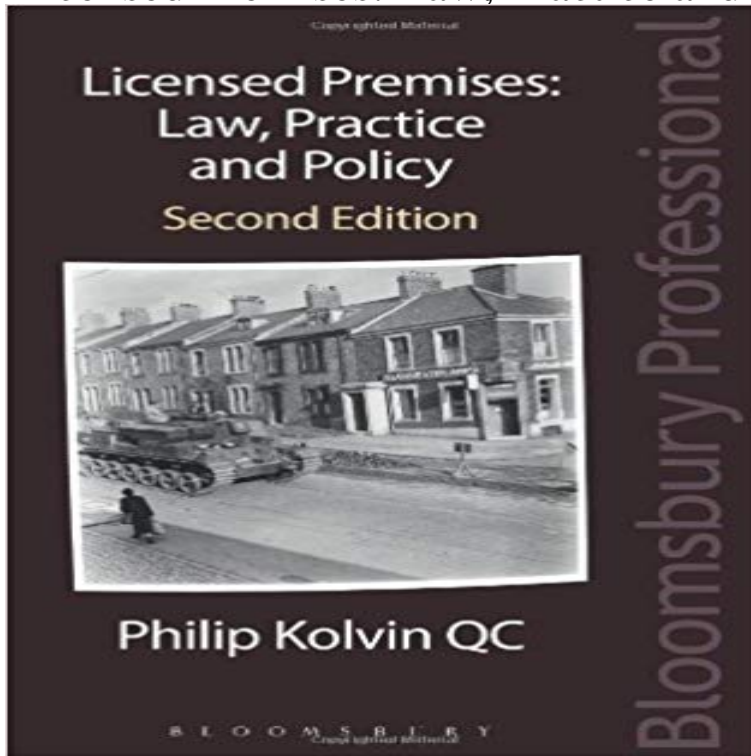


## Licensed Premises: Law, Practice and Policy: Second Edition
