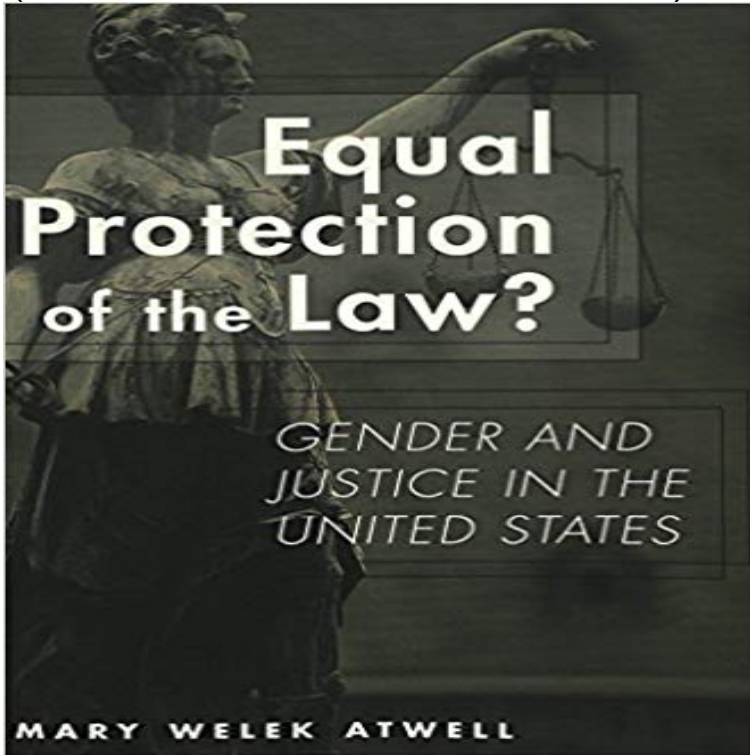


## Equal Protection of the Law?: Gender and Justice in the United States (Studies in Crime and Punishment)
