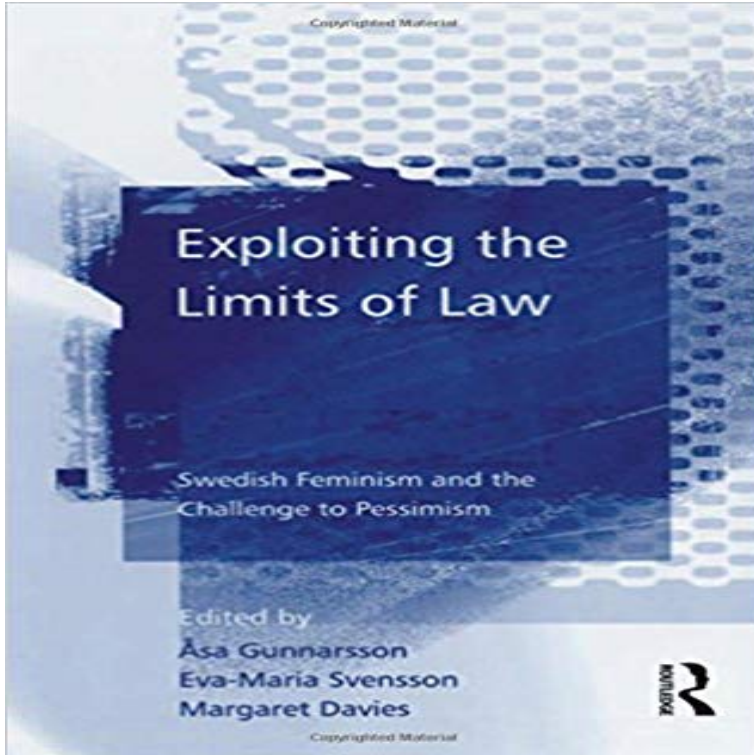


# Exploiting the Limits of Law: Swedish Feminism and the Challenge to Pessimism



Moving beyond the question of whether an area of scholarly investigation can truly be characterized as legal, *Exploiting the Limits of Law* combats the often unhelpful constraints of laws subject-matter and formal processes. Through a process of reflection on the limits of law and repeated efforts to redraw them, this book challenges the general sense of pessimism among feminists and others about the usefulness of law as an instrument of change. The work combines theoretical analysis of the laws boundaries with investigation of the practical settings for changing legal and policy environments. Both the empirical focus of this volume, and its underlying theoretical concern with the limits of the law and its gender implications, render it of interest to legal scholars throughout the world, whether of EU law, feminism, social policy or philosophy.
