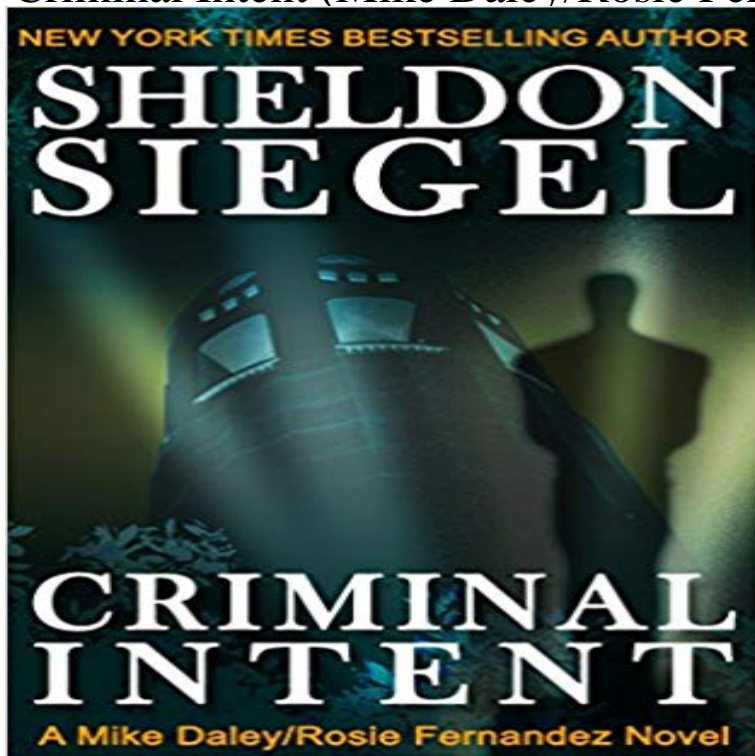


Criminal Intent (Mike Daley/Rosie Fernandez Legal Thriller Book 3)
