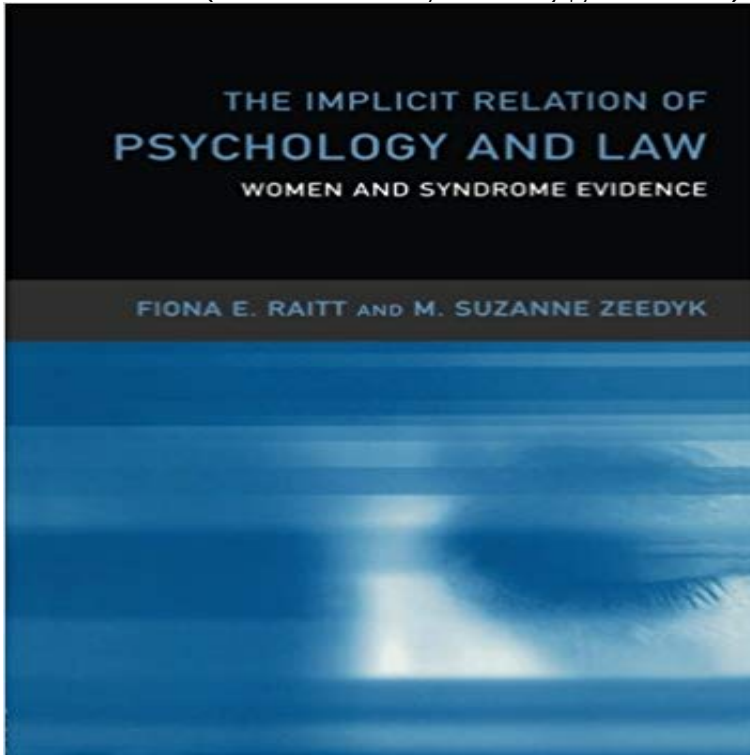


# The Implicit Relation of Psychology and Law: Women and Syndrome Evidence (Critical Psychology Series)
