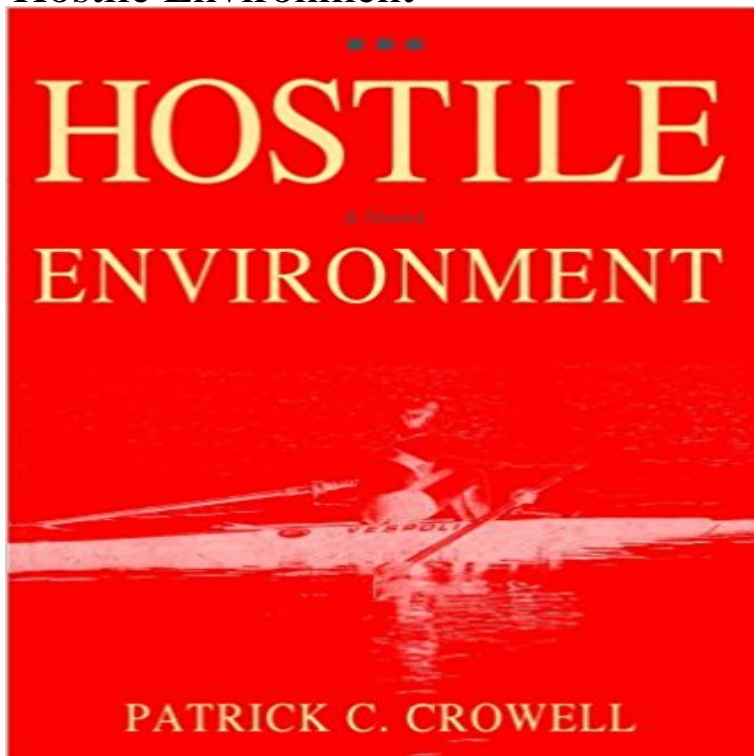


Hostile Environment
