This book is a step-by-step legal practice guide for attorneys and self-represented individuals or small businesses in California who want to know how to remove negative online reports from search engines on the internet. This book presumes that all or at least most of the online report is false and offensive. It provides legal avenues for how to proceed against an anonymous individual, an individual whose location is unknown, and available options if the statute of limitations has elapsed. A full sample state complaint, federal motions, and direction with links on where to find subpoenas and other forms are provided with discussion of applicable caselaw. The book also addresses how to prepare a settlement agreement (fully applicable sample provided) with the reports author and how to present the order (fully applicable sample provided) to the major (Google, Yahoo, Bing, etc.) search engines for de-indexing/de-listing/removal from internet searches (and how to craft the stipulated judgment in case the review sites decide to re-index the negative report). This book is written with a focus on California civil procedure and federal civil procedure, but the procedures will be similar to most states in the United States, and the federal court discussion may mimic international jurisdiction, as well. This book is not intended in any way to create an attorney-client relationship with the reader, but is rather an educational tool and guide for the attorney representing the devastated person or business owner, giving hope to those who have been harmed by false, negative and defamatory online reviews. Eventually, the techniques in this book will probably become obsolete should Congress amend Section 230 of the Communications Decency Act of 1996 in

the United States or search engines relegate all review sites to a separate tab on their sites, making them much less visible or otherwise de-emphasizing all review sites in general. The reader should note that this guide does not make guarantees or promises, especially with regard to removing reports from the main review websites themselves, as this is not possible in all cases, but the focus is on removal from search engine queries where most viewers go to conduct a search of the individual or business.
