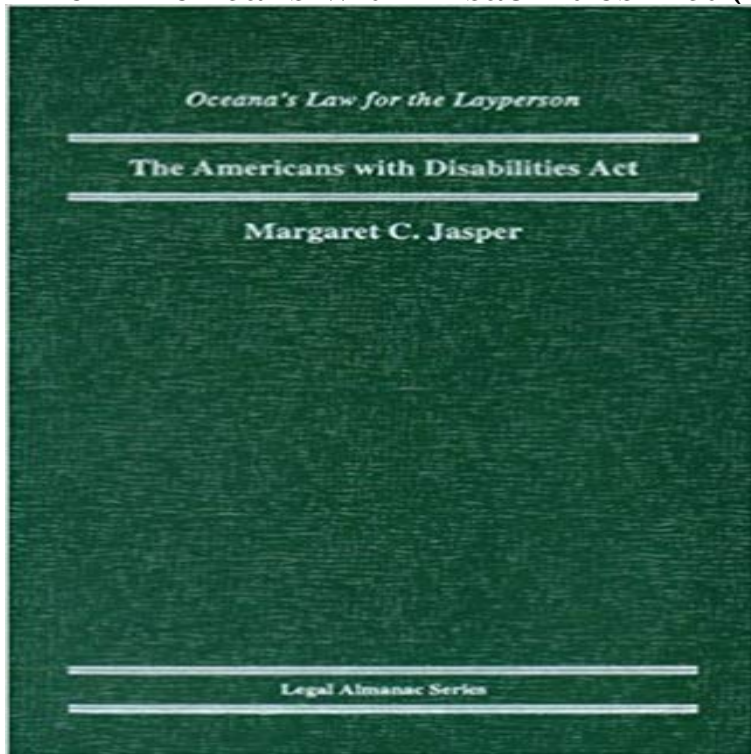


## The Americans with Disabilities Act (Legal Almanac Series)
