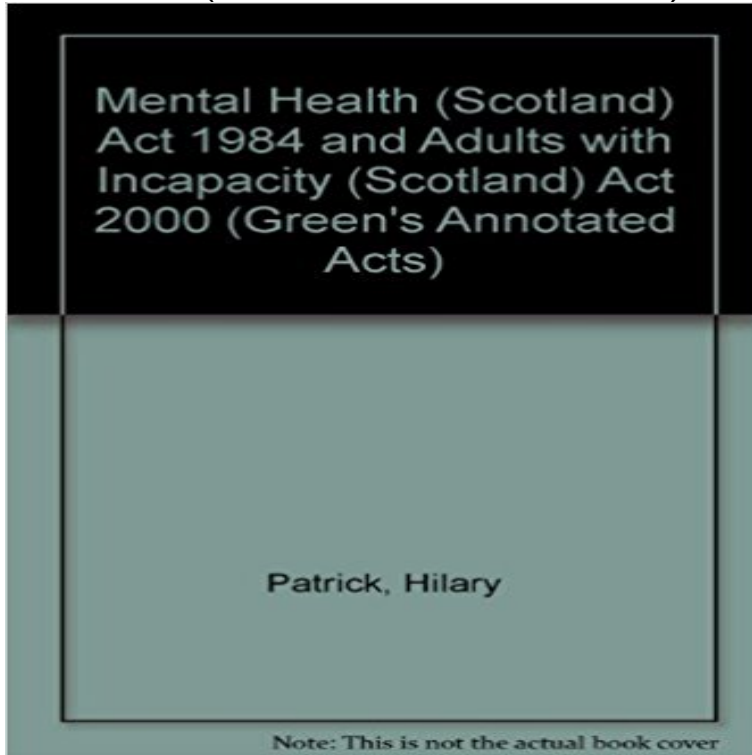


Mental Health (Scotland) Act 1984 and Adults with Incapacity (Scotland) Act 2000 (Greens Annotated Acts)
