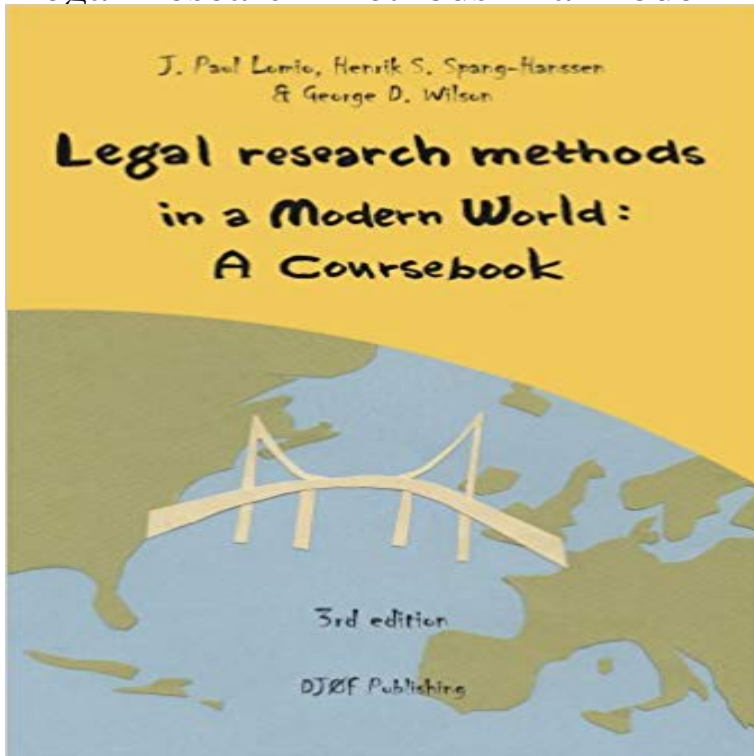


Legal Research Methods in a Modern World: A Coursebook
