It goes without saying that in no case could the means in question he applied to questions concerning interior regulation.1 United States Under reservation of the declaration made at the plenary sitting of the Conference on the 25th of July, 1899.2 Extract from the proccs-verbal: The delegation of the United States of America on signing the Convention for the pacific settlement of international disputes, as proposed by the International Peace Conference, makes the following declaration: Nothing contained in this Convention shall be so construed as to require the United States of America to depart from its traditional policy of not intruding upon, interfering with, or entangling itself in the political questions or policy or internal administration of any foreign State; nor shall anything contained in the said Convention be construed to imply a relinquishment by the United States of America of its traditional attitude toward purely American questions.8 The 1907 Convention was ratified by the
