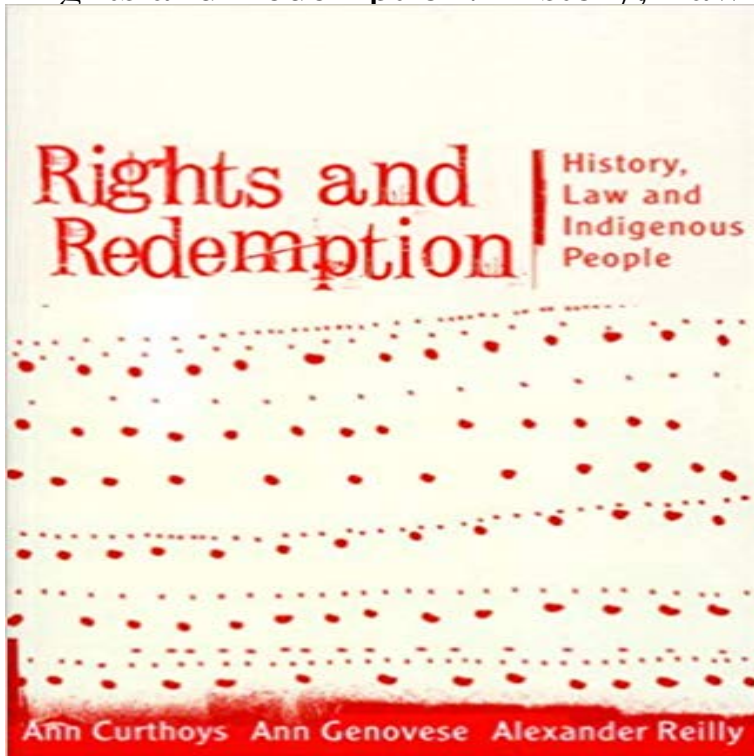


Rights and Redemption: History, Law and Indigenous People
