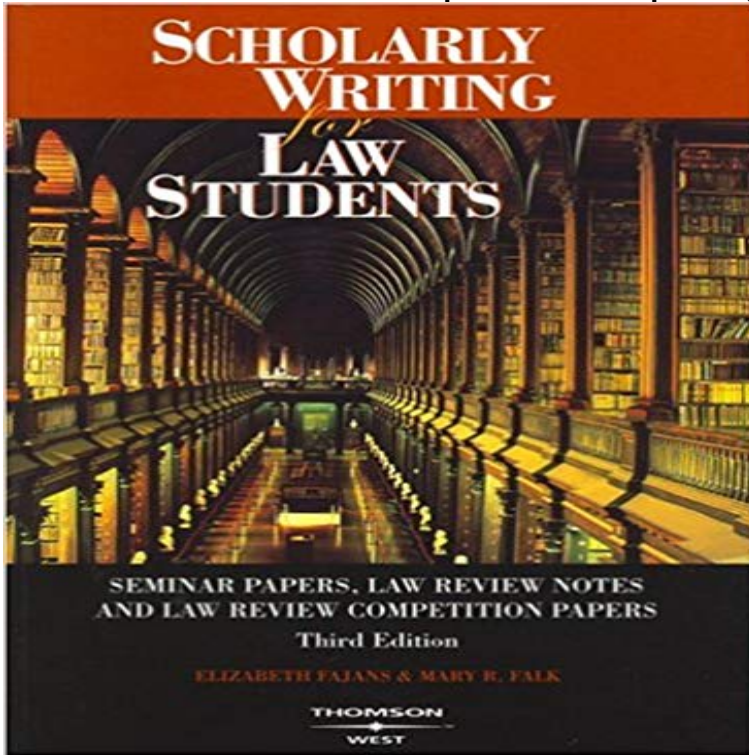


Scholarly Writing for Law Students: Seminar Papers, Law Review Notes and Law Review Competition Papers (American Casebook Series)
