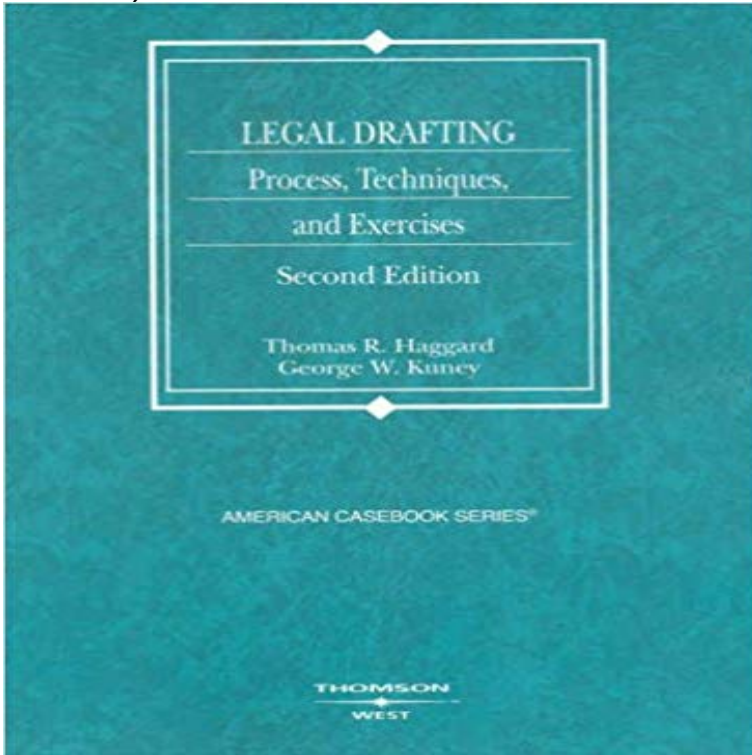


Legal Drafting, Process, Techniques, and Exercises (American Casebook Series)
