

Get ready to be Board! Beyond Law, Rules & Regulations: Governance in Sporting Organizations. This chapter deals with governance in sporting organizations. Whilst the term governance is usually taken to mean how, government or businesses are run and operate, the lessons to be learned from them are equally, if not more, importantly, valid in the context of sporting organizations because, whilst good governance may not make an organization successful, it certainly does it no harm. In this chapter the terms CEO, President, Chairman, Board and Committee are interchangeable from business to sport so in this, chapter the role and responsibilities of the Board of Directors or management committee are outlined and various governance structures are examined. Managing stakeholder relationships, behavioral standards, legal and moral Issues are discussed. What are policies? The boards governance policies, developing, adopting and reviewing governance polices, the CEOs operational policies The role of the board in relation to planning the organizations strategic direction and what the board does not do in relation to planning are discussed, as are the boards processes and practices. Board meetings and board committees are also considered. The role of the Chairman, appointing a CEO, the role and responsibilities, the delegations and decision-making power of the CEO, the CEO - board relationship and with individual members is discussed. The prime function of the board, the continuous monitoring and evaluating of the organizations performance is examined as is the board responsibility towards assessing organizational risk and meeting its financial responsibilities.
