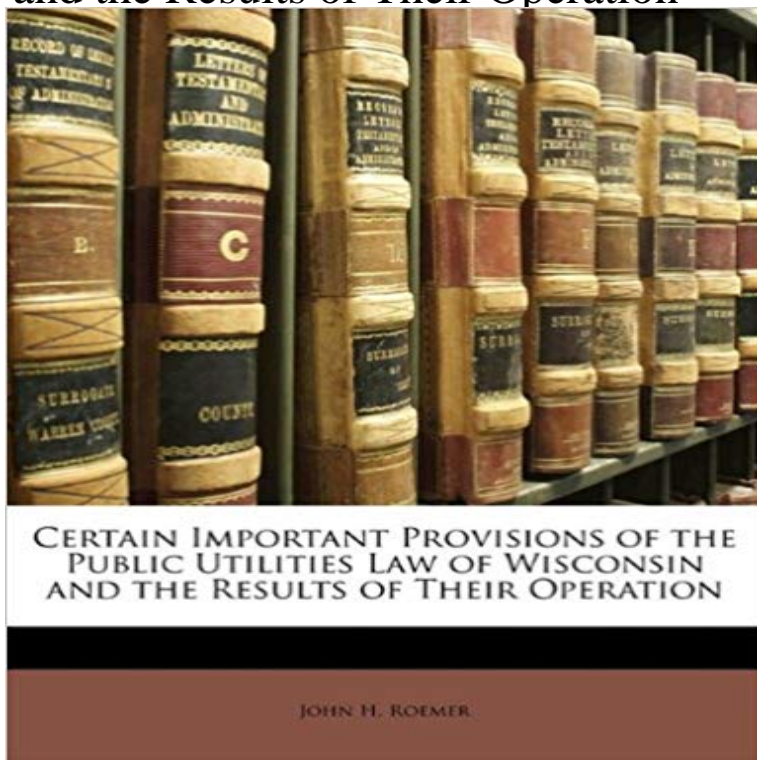


Certain Important Provisions of the Public Utilities Law of Wisconsin and the Results of Their Operation
