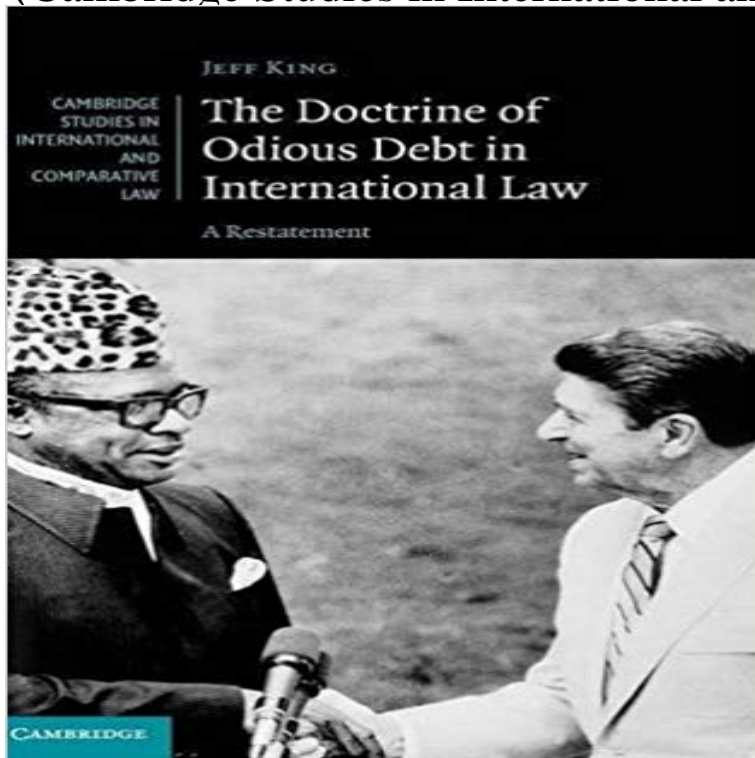


The Doctrine of Odious Debt in International Law: A Restatement (Cambridge Studies in International and Comparative Law)

It restates the doctrine by introducing a new classification of odious debts and defines odiousness by reference to the current, much more determinate and litigated framework of existing public international law. Acknowledging that much of sovereign debt is now governed by the private law of New York and England, Jeff King explores how odious debts in international law should also be regarded as contrary to public policy in private law. This book is essential reading for practising lawyers, scholars, and development and human rights workers.
