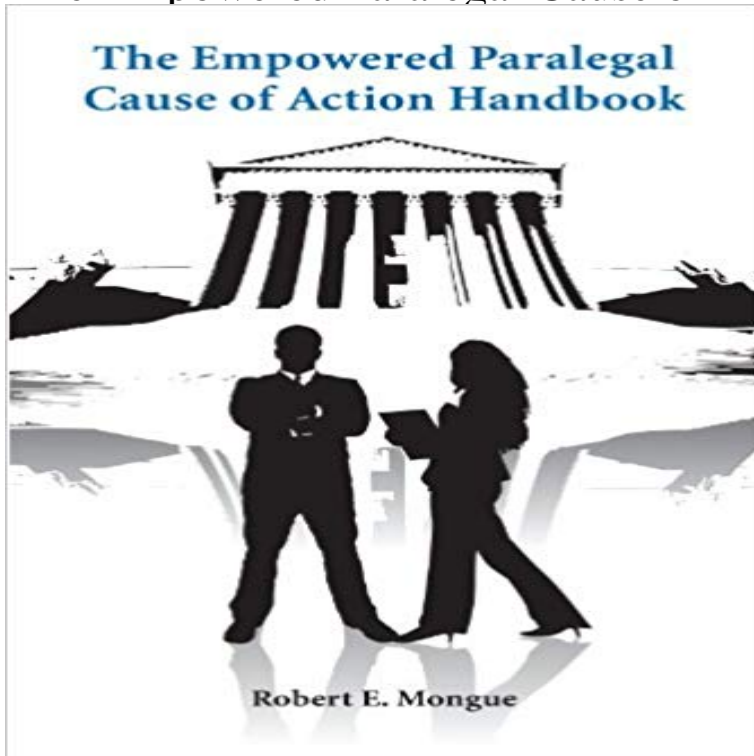


The Empowered Paralegal Cause of Action Handbook
