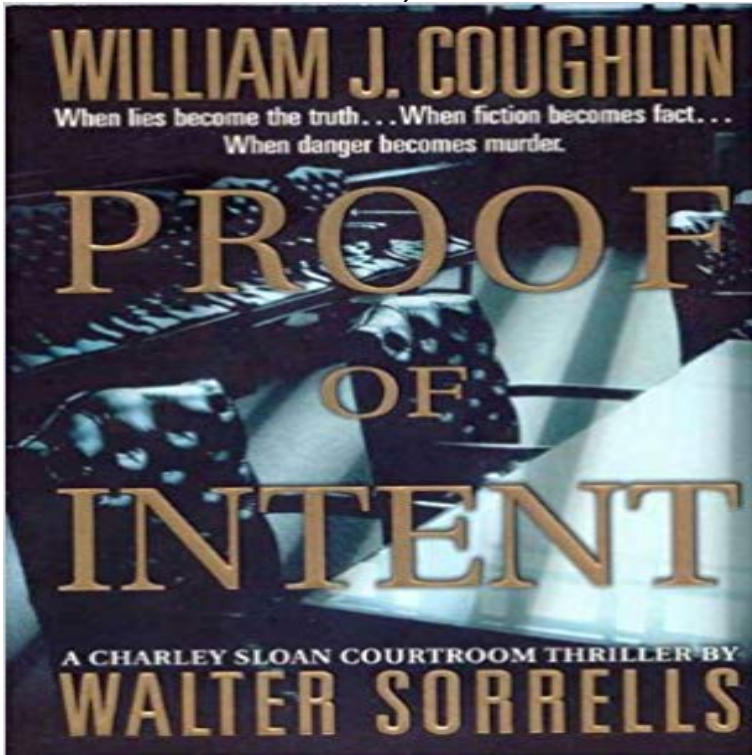


## Proof of Intent: A Charley Sloan Courtroom Thriller (Charley Sloan Courtroom Thrillers)
