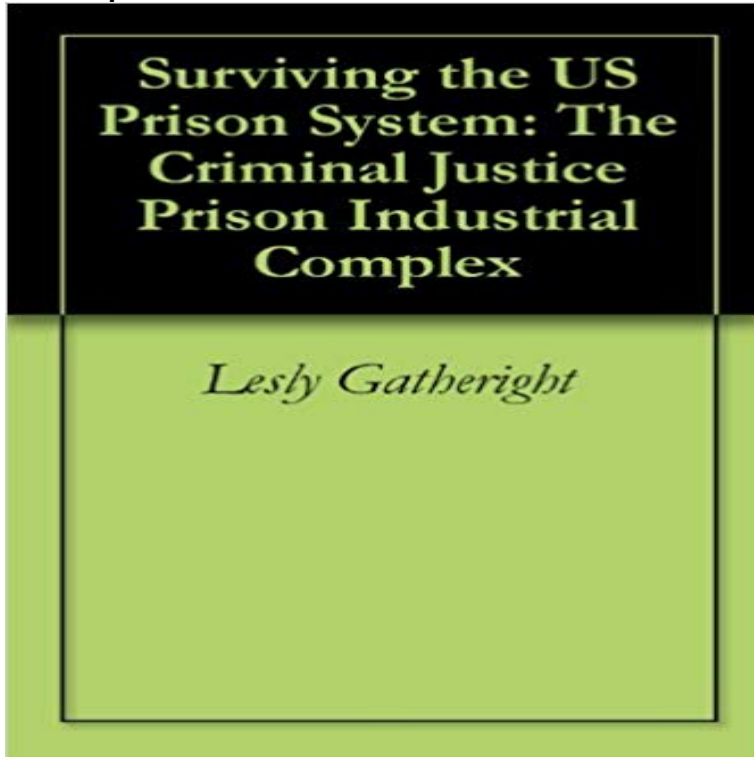


Surviving the US Prison System: The Criminal Justice Prison Industrial Complex



Americas prisons house the greatest resources resident within the black community. Incarcerated individuals possess within their respective spirits, souls, minds and bodies, some of the greatest resources that humanity has to offer. Unfortunately, the existing disparity within the American Criminal Justice System suppresses and restrains the black male, and other disenfranchised groups and individuals, from developing and cultivating these resources. The means with which to grow these natural resources contained within the American Criminal Justice System is through the mental and character development of its inmates; and basically, it is difficult to enslave any individual within the American Criminal Justice system when he or she has a strong will and well-developed character. This is why the American Criminal Justice System must be exposed for privatizing its prisons: as well as its unwillingness to assist with the reformation of its primary commodity; the black male inmate. The prosecutors and judges within the system act as fraternal partners in reinforcing this privatization. In addition to this, the defense attorney, acting within this same situation, represents the various levels of criminal defense available in the marketplace for the accused. At this point, black men accused of crimes find themselves in awkward positions as they relate to the American Criminal Justice System; because generally, blacks accused of crimes, and then arrested and incarcerated, usually cannot afford decent, high quality defense attorneys to defend them concerning their respective legal situations. These desperate positions in which the accused find themselves, is how the Criminal Justice Prison Industrial Complex is formed and reinforced. Furthermore, this system needs a constant stream, or revolving door, of prisoners, in order to support the financial structure of this same privatized Criminal Justice

Prison Industrial Complex. Sadly, the black male serves primarily as the main commodity which enables the system to run efficiently, and lucratively, for its investors, vendors/suppliers and other notable beneficiaries. This criminal justice stock market, created by the vendors and the overseers of the American Criminal Justice System, exposes the utter lack of a viable economic base from which blacks, that are accused of crimes, can tap into for the purpose of securing a quality legal defense; irrespective of their guilt or innocence (I addressed this particular issue in my other books, *Taking It Back* and *Copping A Plea*). In essence, the young black male becomes the primary cash cow for the Criminal Justice Prison Industrial Complex when he gets involved with the American Criminal Justice System (much to his, his family and his community's chagrin). Now, any business which provides a service needs customers to patronize this service in order for this business to either become profitable, or to maintain its profitability; for this reason, privately owned, or privatized prisons in particular, depend upon the black male to maintain a divisive relationship with the American Criminal Justice System. In other words, the black male, and his other financially strapped counterparts who are embroiled in legal battles with the system, are simply the most vulnerable to being used and cheated by the system; because again, they simply do not have the financial resources to pay for quality legal representation when they encounter the overlords and administrators of the American Criminal Justice System. Therefore, current and ex-offenders, who are black males, must take some responsibility for their involvement with the American Criminal Justice System in order to survive its aftermath. Furthermore, ex-offenders must also consider re-ordering their personal priorities in order to manifest change within the American Criminal Justice System: and within themselves as well.
