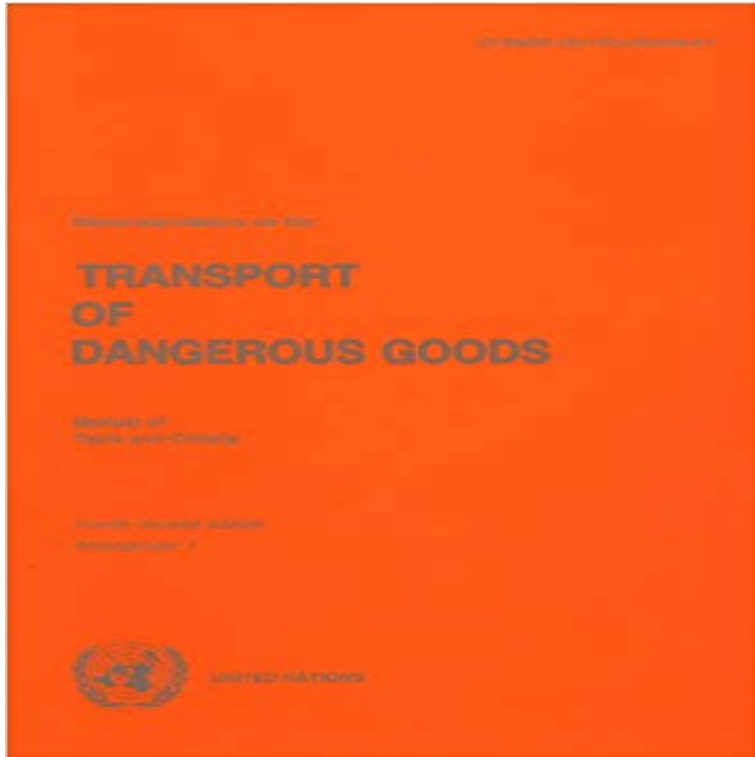


# Recommendations on the Transport of Dangerous Goods: Manual of Tests and Criteria Amendment 1
