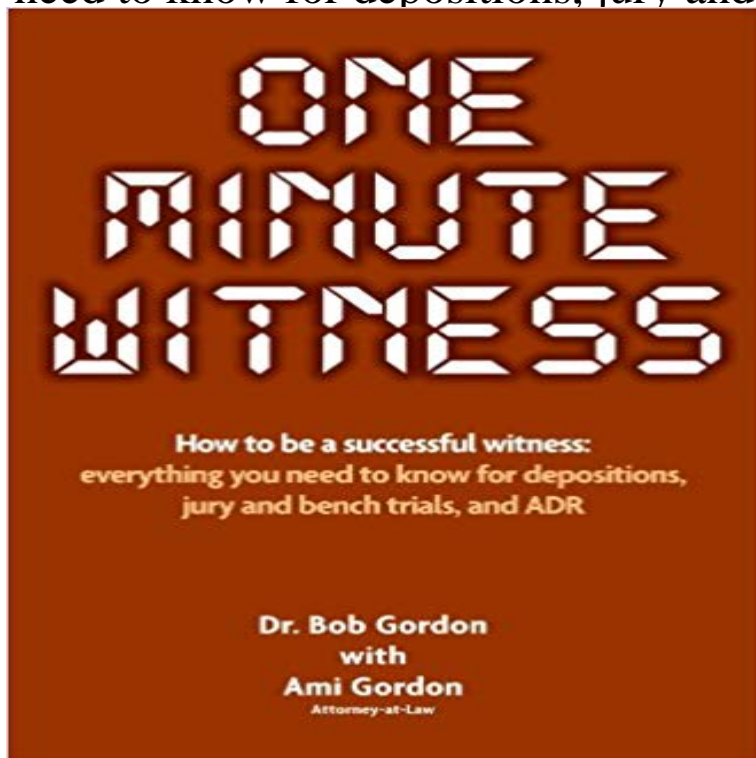


## One Minute Witness: How to be a successful witness. Everything you need to know for depositions, jury and bench trials and ADR.
